2. Composition / Information on ingredients

Composition	- Bulk blended with powders and / or small granules and / or crystalline products. A mixture of nitrogenous (13.9-15.8 / 11.5-13.3% N), phosphatic (3.8-4.2 / 3.2-3.7% P) and potassic (7.8-8.9 / 12.2-14.0% K), (H ₂ O (<3 / <3%) and Cl (<1.5 / < 2.0%) materials for Biogro 513 / 514 respectively.
Appearance	- White to dark grey-brown powder.

3. Hazards identification

Effects and symptoms	- Dust may cause irritation to skin and eyes. Ingestion of small quantities may cause gastrointestinal irritation. Ingestion in large amounts may cause vomiting and collapses. Inhalation of dust may cause a burning or stifling effect,

4. First Aid measures

Specific immediate treatment	
Inhalation	- If inhaled, remove to fresh air. If not breathing, give artificial respiration. If breathing is difficult, give oxygen. Get medical attention if symptoms appear.
Ingestion	- Do NOT induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Loosen tight clothing such as collar, tie, belt or waistband. Get medical attention if symptoms appear.
Skin contact	- In case of contact, immediately flush skin with plenty of water. Remove contaminated clothing and shoes. Wash clothes and shoes before re-use. Get medical attention if symptoms appear.
Eye contact	- In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Check for and remove any contact lenses. Get medical attention if symptoms appear.
Notes to physician	- Support respiratory and cardiovascular function.

5. Fire-fighting measures

Suitable extinguishing media	
Special fire-fighting procedures	- Non-flammable. Intense heat may cause smouldering. Floating under confinement may cause an explosion.
Protection of fire-fighters	- Fire-fighters should wear positive pressure self-contained breathing apparatus (SCBA) and full turnout gear.

6. Accidental release measures

Spill and leak	
Personal Precautions	- Dam or dyke spillage with absorbent material or earth. Use only with adequate ventilation. Wear suitable protective clothing. Avoid breathing dust. Avoid inhaling dust and eye irritations caused by dust.
Environmental precautions and clean-up methods	- Use shovel to put the material into well labelled and convenient waste disposal container. Prevent material from contaminating water sources and supplies. Do not clean-up or dispose except under supervision of a specialist.

7. Handling and Storage

Handling	- Do not ingest. If ingested, seek medical advice immediately and show the container or the label. Avoid contact with eyes and inhalation of dust. Avoid creating dust when handling and avoid all possible sources of ignition (spark or flames).
Storage	- Keep container tightly closed. Keep container in a cool, well-ventilated area. Store and use away from organic materials, reducing agents, moisture and powdered metals.
Packaging materials	- Use original container.

Skin and body protection	- Full length chemical resistant overalls / apron, dust mask.
Hand protection	- Gloves (Impervious)
Eye protection	- Use dust goggles / masks if high dust concentration is generated.

Appearance / Colour	- Powder and / or small granules and / or crystalline material. May vary from white to dark grey-brown colour.
Bulk density	- 1.1 to 1.4 g/cm ³ at 20 °C
pH	- 1.5 to 2.2 containing free H ₂ PO ₄ ⁻ (In 1.1 aq. Dilution by volume) 5 to 7 no free H ₂ PO ₄ ⁻ (In 1.1 aq. Dilution by volume)

10. Stability and Reactivity

Stability	- Stable under recommended storage and handling conditions.
Hazardous reaction	- Keep away from strong oxidizers and strong reducers which may cause nitration.
Hazardous decomposition products	- On exposure to intense heat the material may yield ammonia, oxides of nitrogen.

Potential acute health effects	
Eye contact	- Hazardous in case of eye contact.
Skin contact	- Hazardous in case of skin contact.
Inhalation	- Vapour / dust may cause irritation to the respiratory tract which may cause coughing and choking.
Ingestion	- May cause gastrointestinal disorders and large doses may cause nausea, diarrhoea, vomiting and / or collapse. Nitrates cause dilation of blood vessels, methaemoglobin formation, low blood pressure and decreased blood oxygen carrying capacity.
Chronic effects	- Those with history of cardiovascular disease may have aggravated reactions to overexposure.
